

## **Textile production and trade in Europe during the second millennium BC**

This workshop will examine the significance of textile production and trade in Europe and the Mediterranean during the second millennium BC. In order to achieve the most comprehensive understanding possible of the issues at play the workshop seeks to explore topics which include the analyses of both archaeological and textual evidence.

The main questions that we wish to examine are:

- How common was textile production in Bronze Age Europe and the Mediterranean? How important was it?
- Did the concept of specialisation exist, e.g. in the form of workshops/households?
- How important was the role of textiles (wool, yarn or finished products) in local economies? To what extent did this vary between different areas?
- Comparing available written sources from the Mediterranean and the Near East and corresponding archaeological material, what can be inferred about the scale and significance of trade and specialisation of textile production in other parts of Europe during the Bronze Age?
- Can scientific analyses/methods help us to understand the questions of specialisation and trade of textiles?

The proposed programme is therefore divided into two parts: the first has a specific focus on textile production and specialisation and the second on trade and mobility as each relates to textiles. Each session begins with a series of papers and concludes with small group discussions in which the theme will be considered in greater depth. The proposed topics for the invited speakers are therefore intended to represent work in progress and provide food for thought rather than reports on finished work.

This workshop is an initiative taken within the research project “The Rise of Bronze Age Societies: Travel, Transmission and Transformation” (for more information see: <http://the-rise.se>). The main aim is to assemble researchers working on textile production and trade during the Bronze Age in Europe and the Mediterranean to facilitate critical discussion on the current state of research in the field and to discern and outline potential directions for future work.
